KEY OPERATING DATA OF 2023 THIRD QUARTER

This announcement is made pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Suntien Green Energy Corporation Limited (the “**Company**”) hereby announces the key operating data of 2023 third quarter of the Company and its subsidiaries (collectively, the “**Group**”).

NEW ENERGY BUSINESS SEGMENT

According to the Company’s preliminary statistics, the power generation of the Group on a consolidated basis for the 2023 third quarter amounted to 2,359,411.93 MWh, representing a decrease of 0.83% over the corresponding period of 2022; the on-grid power generation amounted to 2,299,873.61 MWh, representing a decrease of 0.74% over the corresponding period of 2022. As of 30 September 2023, the accumulated power generation amounted to 10,172,592.08 MWh, representing an increase of 1.32% over the corresponding period of 2022; the accumulated on-grid power generation amounted to 9,940,113.77 MWh, representing an increase of 1.42% over the corresponding period of 2022. From January to September 2023, the average on-grid tariff (tax exclusive) of the Company was RMB0.44/KWh, representing a decrease of 1.24% over the corresponding period of 2022; the Group’s transacted electricity volume in the electricity market amounted to 3,940,281.02 MWh, the proportion of transacted electricity volume in the electricity market amounted to 39.64%, representing an increase of 17.84 percentage points over the corresponding period of 2022.

GAS BUSINESS SEGMENT

According to the Company's preliminary statistics, the transmission volume of gas of the Group on a consolidated basis for the 2023 third quarter amounted to 903.6372 million cubic meters, representing an increase of 26.66% over the corresponding period of 2022, of which, the sales volume of gas amounted to 769.8244 million cubic meters, representing an increase of 30.28% over the corresponding period of 2022; the volume of gases transported by the Group for its client amounted to 133.8128 million cubic meters, representing an increase of 9.20% over the corresponding period of 2022. As of 30 September 2023, the accumulated transmission volume of gas amounted to 3,288.774 million cubic meters,

representing an increase of 3.78% over the corresponding period of 2022, of which, sales volume of gas amounted to 2,829.2803 million cubic meters, representing an increase of 1.84% over the corresponding period of 2022, the volume of gases transported by the Group for its client amounted to 459.4936 million cubic meters, representing an increase of 17.50% over the corresponding period of 2022.
